PASTOR'S REPORT

I don't even know how to begin talking about the year 2020 at the church. It began with anxiety with people not doing particularly well with health conditions and then moved into full Covid-19 crisis. It was a year of finding entirely new energies to reinvent ourselves over and over as we sought to adjust to the circumstances for which none of us had a fully developed toolset. In truth, we did quite marvelously and the resources that came from within the congregation were astounding.

Throughout the year we faithfully participated in the Vital Congregations Initiative program both as a congregation and as a task force applying what we were learning to our own situation. There was some significant difficulty with the VCI program in that we were not able to effectively communicate: not even as well as our less-than-optimal norm. We were not coming together in ways that were effective for holding conversations. Yet the task force has met regularly, we held studies on the seven marks of a vital congregation and worked hard to evaluate where we stand on each one of those markers. There was preaching around the seven markers during Lent and again in the summer. At both points we sought to refresh and evaluate our growing understandings of what the markers showed about our congregation. Moving through the fall we worked put together a history of the church relative to its vitality both through interviewing members and exploring what community might know about our congregation. Toward the end of the year, we were invited to take an every member survey and we are waiting for the results of that survey to help guide us toward the continuing unfolding of the initiative in this calendar year.

In support of the VCI, I have attended many meetings and develop deeper relationships with my colleagues in ministry. I love the way that congregations are coming together to support one another. In another way though, the Covid crisis has brought about the reevaluation, or a new evaluation of how we do ministry in the 21st century that is probably more in depth and more energized than anything we have or are likely to find emerges out of the VCI work.

For my report, let me walk through the seven marks of vital congregations from my perspective.

The first mark is lifelong discipleship formation. Here, we have remarkable variation within our congregation. There are a good number of us who take our faith very seriously and use it to inform virtually every day of our lives. I have been wowed by the number and quality of the education offerings and participation that have taken place during the pandemic. Many of us are active in worship and active in the community seeking to live out the teachings and values of the Church. Receiving from our community of faith and living the values in the community is the essence of discipleship. There are others among us who are quite comfortable being part of but perhaps less invested in what is happening within the congregation. For some, there seems to be a sense of living out our Christian values in the community, without as clearly identifying what exactly are the values that we receive from our Lord as

opposed to the assumptions of Christian values that permeate our society.

The second mark, intentional, authentic evangelism, is one that feels a bit more difficult for me to pinpoint. Perhaps I'm pointing at my own feeling here, but I think my evangelism is very authentic, but perhaps not adequately intentional. What I mean by that is I very much seek to live as a person of God and my faith is very important to me in the midst of my life, I'm even happy to tell people about how much my faith means to me. But I'm hesitant to start conversations with people I don't know or to ask them to become part of our faith community, so I too often remain silent even when the opportunity to share my faith seems present. However, the online presence has given opportunity to gently invite others to experience our church. I find when I share worship on my personal Facebook page, or when others do, we have a great response. I have been shocked by the number of folks who comment on what they received from our worship when they are invited through a "share."

The third mark is outward incarnational focus. I think this is the place where Lakewood Presbyterian Church really shines. Almost to a person members and friends of the congregation live their faith in the larger community. It is interesting how much easier it seems to be to live our faith than to talk about it. While I love what we do as a church together, I am even more impressed with what we do with the days of our lives. We support one another, and we support the people who people our worlds in ways great and small.

The fourth mark is to empower servant leadership. This is another place where we genuinely shine. Perhaps because I've always been here in a part-time position, and perhaps because the people that we have elected to leadership over the years are just and strong people, I have never felt that the church is in danger of monopolized leadership from the pastor. I guess this is a time to talk about how very humbled I am by the energy, quality, and genuine goodness that is put forth by the people who lead the church. This includes the deacons and elders, people who have served as treasurer, financial secretary, bulletin preparation, maintenance of records, maintenance of facility, and so very much more. We are a congregation that has always PUNCHED WAY ABOVE OUR WEIGHT in our service to the community both within the church and beyond the church.

The fifth mark is the Spirit-inspired worship. On this one I feel little uncertain. I can say the preaching is solidly biblical, and the theology is well studied. I can also say that those involved in the music have always had a remarkable heart for worship. What we are learning through needing to remake our worship for the online environment would suggest though that our worship has been in something of a rut. The guitar group has been hugely beneficial for nudging us into awareness that changing things up was beneficial, but the format does not work online. Going forward, I'm not sure how to make our worship more relevant to people who may want to be part of our congregation, but I do feel that this is a piece of our life together that needs to be considered very deeply.

In no small way, having visibility through digital platforms is really expanding our reach into our community. I would guess, when Covid is over, we will continue to maintain a digital presence and I profoundly hope that we connected with people who have discovered us during the time our building has been mostly closed. Remarkable beauty has been added to our worship through the PowerPoints that show up in Zoom and on Facebook and through the expanded order worship. We are all

amazed at the way the art has helps to bring home the message and inviting a deeper sense of Spirit in the midst of our worship. I do miss being able to sing altogether in the sanctuary yet am humbled by the diligence and generosity of those who lead our music in worship. The future will find a way to combine the best aspects of sanctuary worship with the best aspects of digital worship so that we can share God's love as broadly as possible.

The sixth mark is caring relationships, and this is another place where I think we do very well. I once read that "churches the one place where we go and relate to people who we otherwise would have very little to do with." That remark has always struck me because of the unlikely community that exits in a congregation--the way we move across most all of life's barriers to be together as a community of faith. I celebrate how we have kept in touch in this time of physical distancing.

That said, we do remain very white especially given the rich tapestry of humanity that makes up Lakewood.

The seventh mark is ecclesial health. This is another place where we are remarkably strong. We have had strong participation in all of the Presbytery meetings, and we have nurtured many of the people that make Presbytery quite extraordinary. Our commitment to giving a tithe to Presbyterian General Assembly is unique in the Presbytery and very unusual in the denomination nowadays. I love the diligence with which we protect that practice. We continue to support the large judicatories when we disagreed with decisions being made as well as when we were in agreement with decisions being made. Still, I think we could use a more discovery of why we are a church community and what that means and being connected to the larger body of believers both within Lakewood and beyond. Participating with Fircrest, Bethany, Immanuel, Urban Grace, Skyline, and St. Mark's Episcopal Church through the youth group was really great, and I hope something similar can be found in the future to weave various congregations together in meaningful ways. I would like to see more of a coming together of churches in the Lakewood beyond the great relationship we have The United Methodist Church of Lakewood.

A special thanks this year to so many people. Lorraine Maidia is responsible for the beautiful PowerPoints we use in worship and Dan Evans who makes the order of worship beautiful by adding the art. We cannot thank Jennifer Matson or Candice Cochran enough for keeping worship worshipful. Chris Piatt along with Lorraine and Connie has kept adult education meaty and relevant. Jim Hall as treasurer has kept us financially balanced and Jim Weger has continued to keep accurate records of our giving in the midst of the confusion. There are many others who I should name, but I am at the end of page 3 and this is getting very long, so I just want to thank you all for the continued support and love.

TREASURER'S REPORT

2020 has been a challenging year for Lakewood Presbyterian Church. We started out fairly well financially and looked forward to a 'normal' church year. Obviously, that isn't what has happened.

In February/March the COVID-19 virus appeared, and we were forced to move our church services from the church building onto the ZOOM/Facebook Online computer formats. While we were able to continue the church services, our attendance has suffered, and our giving has suffered as well.

We did implement a program that allowed ONLINE giving through a computer program. Some people have participated in the program and find that it is a convenient way to contribute to the mission of Lakewood Presbyterian Church. This ONLINE computer program allows people to donate using their credit card for donations. I have heard that many people like this feature because previously they wrote one check a month – for their church pledge. Online giving is much more convenient.

We were fortunate in that the US Government created a program called Payroll Protection Program (PPP) that I signed up for and that we received. PPP is a loan program that allowed us to continue to pay our employee payroll as well as health benefits, utilities or any other expenses that might be challenging for a total of three months. The loan was forgivable if we met certain criteria AND we did. The PPP loan has been forgiven.

In addition, the National Presbyterian Church Board of Pensions forgave three months of Health Insurance/Pension for the pastor. This was also a welcome savings.

All in all, we have survived 2020 and we hope for a better 2021.

I believe there will be another PPP forgivable loan program coming soon and I plan to apply for that program as well.

While we have been fortunate in obtaining the extra funds through the PPP and three month healthcare/pension forgiveness for 2020, we are trying to build up our fund reserves for several reasons. With Barlow's upcoming retirement, it is uncertain what our financial responsibilities will become related to the pastor position. In addition, our Building Insurance has significantly increased.

BUDGET COMMITTEE REPORT

When we created our budget for 2020 there was the expectation that we would have a pretty normal year of giving and expenses. Faith is a big part of trying to plan for what is to come, and I am happy to say that we did well financially in 2020. Giving was down a bit, but so were our expenses. We were able to take advantage of the Covid-19 relief program and received some money to put towards our payroll expenses. A big thank

you to Jim Hall for the research, filing of applications and providing the documentation needed to make that happen.

Planning the budget for 2021 was a bit of a challenge. You will notice that our budgeted income for 2021 is below what our budgeted expenses are expected to be. The loss of income is partly due to the loss of pledging members of our congregation. We do not expect as much loose plate and un-pledged giving since we will not be meeting in person for a while. Income from church usage has gone down. Many of our expenses are fixed whether we are using the church or not. We based our budget on the hope that we will be able to physically meet again in late 2021. We expect more expenses during our search for a new pastor following Barlow's retirement. We are very fortunate to have money in our general fund to cover any shortfall in 2021.

We turned to the Presbyterian USA Book of Order and our Session for guidance on how to proceed safely and continue worshipping together – at a distance. Elder Dan Evans jumped right into the technology to find a way to keep us worshipping together. Barlow Buescher put together the worship service and continued to guide us through the discomfort of our world and provided meaningful sermons. Karen Johnston proofread the outline of the service before it went out to the congregation. Jennifer Matson played the keyboard, Candice sang the hymns, Lorraine Maida put together the PowerPoint presentation of the worship service and presented it during the live service; Dan Evans as our technology director and communications sent email links to members; our many worship leaders presented their part on Zoom from the comfort of their homes. Kelsey Boyce assisted with production of kids' video; Kelsey also sang "This Is My Father's World" with Kurt Sample with a video featuring the beauty of Camp Soundview. Our children lit the advent candles and to our delight we had a wonderful Puppet Show from Jennifer Duran, her husband Eric and son Lucas telling their version of the Christmas Story.

Called Congregational Meeting December 16, 2019

Rev. Buescher invited nominations from the floor. None were made. A motion was made that nominations be closed. The motion was seconded and passed.

The slate was voted with unanimous approval.

Called Congregational Meeting January 26, 2020

Terms of call for Rev. Barlow Buescher were approved.

Stated Session Meeting April 26, 2020

Jennifer Rogiers agreed to prepare a letter to the church about the need for continued regular giving during the COVID-19 crisis and the availability of the new Online Giving tool. Vicki McCollom will send the letter to all members.

Jim Hall explained the church's eligibility for the Payroll Protection Program of the CARES federal legislation. It was moved and seconded to approve Jim submitting an application for about \$13,500 under the program. After some discussion, the motion was approved.

It was moved and seconded that Barlow be given the authority to research and spend up to \$300 for a cellular equipped camera that will provide a means to remotely monitor activity in the upper lot. After discussion the motion was approved.

To assist with continuing operations in light of the COVID pandemic, it was decided to procure a regular license for Zoom, establish an account with the Presbyterian Foundation for online giving, and pursue a \$13,500 loan through the Payroll Protection Program.

Called Session Meeting April 1, 2020

After some discussion, it was moved that we continue to pay our staff through this crisis to the best of our ability and with the expectation that the employees would continue to serve the interests of the church to the best of their abilities. The motion was seconded and the vote unanimously approved the motion.

Stated Session Meeting June 7, 2020

Established guidelines for in-person worship when state restrictions permit. To start, the in-person participation will be limited and online (Zoom) streaming will be the primary vehicle. The initial group will be limited to 10 participants who will be invited directly. All attendees will be required to wear masks and adhere to social distancing.

BUILDINGS, GROUNDS & USAGE

For building and grounds and building use it has been a very different year. Because we have not been in the sanctuary or utilizing the church as a congregation, we have not had as much opportunity to participate in facility maintenance, as is our norm. However, the preschool has continued to be as active as possible in the church building. The preschool has moved their primary gatherings to outside and as a result it's some

remarkable work fixing up the patio in the back area of the church. We appreciate their efforts.

There was one leak in the fellowship area, but we think we have attended to that and are OK until the weather works to do something more permanent.

There has been a lot of dumping in the upper parking lot, so, at the December session meeting, it was decided to rope off the access to the upper parking lot that is closer to 104th St. We are still in process of getting that accomplished, though it might be done before this note goes out.

Because the preschool has lost so many enrollments, and because their meeting schedule is so iffy, they are essentially only paying a maintenance fee of \$150 a month for use of the church building and facilities. We understand that this is less than the cost of having them there, and yet believe that the relationship is valuable enough to protect as much as we're able.

We have managed to bring in Wi-Fi, which allows us to broadcast our worship from the sanctuary. We have also purchased a good quality projector so those in the sanctuary can track what is happening on Zoom.

We have been able to maintain the grounds and the facility reasonably well given our limitations. That said, we have not been able to take care of replacing the support beam in the basement, as we cannot safely get people together to be able to lift the beam, which we do have, into place. The roof repair on the basement area seems to be holding well.

We have worked with Lakewood Rotary to install a little free pantry on the church property, and you really can't miss it when you drive in. Jamie Simons is taking lead on the project for the deacons. Additionally, we have significantly more people using the big toy in the backyard as a safe place to get away and enjoy their children. We understand it's a little thing, but anything that we as a church can do to make life better for people in our community, we are very happy to provide.

We genuinely hope that the year to come will provide us with opportunities to use our facility more effectively in supporting the community.

VITAL CONGREGATIONS INITIATIVE

The Vital Congregations Initiative completed its first year of study and reflection. A VCI Task Force was created to guide progress and met throughout the year. Beginning in the Lenten season, a series of study discussions were held focused on the 7 Marks of a Vital Congregation. Two of these sessions were conducted in-person after worship and the others were conducted via online Zoom meetings. Led by members of the Task

Force, these meetings provided an opportunity for all interested church members to explore the 7 Marks and share their experiences at LPC.

In the late Spring and early summer, the Task Force focused on the "story" of Lakewood Presbyterian Church. This included building a summary of the church's history and reflection on some of the factors that make LPC unique and vital. The pandemic restriction on gatherings meant that much of the planned study under VCI could not be completed. Of most significance was the VCI task of in-person visit within the Lakewood region to get a better understanding of our surrounding community, its characteristics, its needs, and its strengths. Since these visits could not be conducted, the Task Force decided to engage in a series of telephone interviews and conversations with a selection of community leaders and organizations as well as members of LPC. Through the last few months of the year, more than 15 interviews were conducted with respondents including leaders in local schools, teachers at a local college, community and senior center staff members, local business owners, and long-standing members of LPC. These interviews are being summarized in two reports: one for LPC member responses and one for responses from community leaders and Lakewood general population members.

A survey was prepared by the PC(USA) Research Services aimed at collecting solid data on the vitality and status of church's nationally. The survey was designed to be completed by all members of each church. Congregations participating in the VCI participated in the survey and will receive an analysis of the responses for their church with comparison to other churches. We received the surveys in December and followed a schedule that resulted in members completing surveys by early January. The completed surveys have been returned to Research Services who will tally the results and provide our analysis probably by late January or early February of 2021.

CHRISTIAN FORMATION

in order to bring Marilynn Susich to worship, the class has been much reduced. Still, the group is faithful in whatever ways possible. Art and Brad come to the sanctuary each Sunday since neither of them is able to participate in worship online. And Wayne shows up each week.

We hope when we can come together in person again, we will be able to reconstitute the study to the benefit of the participants and of the whole congregation.

Christian Education for Children

While starting the year in strong position on Christian education for our youth, the Covid crisis did a lot of damage to our efforts.

In the beginning of the year, we were well resourced for both the nursery and children's education with Kira and Veronica. However, when we had to stop gathering in the sanctuary those efforts pretty much fell apart, and as we became aware of how dangerous risk of spreading the disease is, even smaller gatherings with the young people became near impossible. While we do believe the parents have done a good job continuing to teach kids at home, there really has not been anything formal for the very small ones since March.

For the youth it was a similar sort of situation. The multi church youth group was beginning to look pretty good at the start of the year under new leadership and taking a new direction. But when the disease hit, we had to move to an online situation, which continued for the older youth throughout most of the spring but was not as effective for the younger youth. Beyond that there were a couple of gatherings in the summer to get the young people together in outside environments, and these were well intended and quite fun, but did not hold the group cohesion as we would have liked. At this juncture, it looks unlikely that the multi church youth group will reconvene even when we're able to get back into our sanctuaries. If it does, it will have to be thoroughly restructured.

Between some pastoral transitions and learning the leader that was so promising decided to go to seminary, it will really be an effort of building from scratch.

Discovering how to get well-resourced education to the youth of the church will be a major focus when we are able to reconvene as a congregation. We strongly solicit your prayers for both the wisdom and the human resource to pull off and create quality education opportunities for our children.

Adult Education Report

The Adult Education Committee met via Zoom 5/7/20 to brainstorm how LPC could continue to offer a forum for adult spiritual growth and formation. We reaffirmed a commitment to finding ways to meet some of our continuing goals in the context of the physical distancing required this past year:

- 1. Involve more of our congregation.
- 2. Give more opportunities for meaningful dialog among people who both agree and disagree.
- 3. Encourage and develop social bonding and spiritual growth.

- 4. Empower LPC facilitators, but also bring in outside speakers who have expertise or different perspectives.
- 5. Be led into service/action as a result of our learning.

There was good energy in the discussion, and the Committee recommendations for 2020 were:

- start an online book club, which could transition to in-person when it becomes safe to do so;
- find a structured bible study program that could be facilitated by congregation members:
- in worship, highlight topics we've studied, so that the congregation is encouraged to continue thinking about our call to outward incarnational focus;
- organize a virtual Brews & Views each month that there is interest;
- reach out by phone or postal mail to involve members who don't have computers or internet postal mailings.

We were able to accomplish a great deal over the remainder of the year, including:

Brews & Views.

We met monthly in 2020, through October. Topics included: Intentions versus Resolutions; Lenten Devotional Discussion; Staying Home/Going Digital; This Moment in Our Nation; How the Gospel Speaks to Injustice and Inequality. Our highlight of the year was an absorbing discussion about our congregation and what we can do to promote racial justice with then-State legislative candidate and CEO of the Tacoma Urban League and now State Senator, T'wina Nobles. By Thanksgiving, we suspended meetings due to "Zoom fatigue," but plan to resume once we are able to gather in person around a table at "the pub" again.

Book Club

Lorraine Maida is leading our new book club that meets for 2-3 sessions every third month. Our selections for 2020 were:

- Sue Monk Kidd's new book, The Book of Longing (a reverential approach to Jesus's life that focuses on his humanity and a "what if" fictional account of one woman's bold struggle to realize the passion and potential inside her, while living in a time, place and culture devised to silence her).
- All We Can Save: Truth, Courage and Solutions for the Climate Crisis; Edited by Ayana Elizabeth Johnson and Katharine K. Wilkinson (illuminates the insights of dozens of diverse women who are leading on climate change, each chapter presents either an essay, poetry or illustrations focused on the climate crisis and what we can do to reshape a society to work toward all we can save).
- Our upcoming book will be New York Times #1 best seller, The Vanishing Half by Brit Bennett (considers the lasting influence of the past as it shapes a person's decisions, desires, and expectations, and explores some of the multiple reasons and realms in which people sometimes feel pulled to live as something other than their origins).

Bible Study

After much research, we chose a recent PCUSA publication, A Guide to Bible Basics, by Tyler D Mayfield for our Bible Study. The church purchased ten copies and provided them to participants. Here's what a review says about the book:

"Wonderfully clear and concise, Mayfield lays out each book of the Bible with a synopsis, outline of each chapter, important characters and places, concepts, and quotations. The format of the book is accessible and perfect for quick reference (it would have saved my life in seminary!). Maps give helpful context and the books are organized into their broader respective categories which makes referencing all the easier. Although Mayfield is writing from a Protestant background, his sensitivity to other traditions whose biblical cannon may differ is to be commended. Perfect for bible studies, seminary students, academic reference, or personal learning, A Guide to Bible Basics is a must-have!"

Dec: The Poetic Books Jan: The Prophetic Books

MARKETING

The marketing efforts in 2020 continued to focus on web services like our website (at https://lakewoodpres.org) and Facebook plus the reader board. With the restriction on gatherings brought on by the coronavirus, most of our effort was put into helping insure that worship and essential meetings had the means to safely provide remote participation. For Sunday worship, the Zoom video streaming service was implemented in March and continued to be used through the rest of the year. Having access to Zoom allowed us to provide not just live worship services but also a platform for committee meetings, adult education classes, and memorial services. An online giving system was

implemented through the Presbyterian Foundation in April that allows donations and payments to the church using credit cards and direct bank transfers.

Starting in August, the technology was installed that allows the live service to be viewed in-person in the sanctuary as well as online via Zoom and Facebook. At that point some 5 to 10 members who did not have access to the online services were allowed to gather in the sanctuary for Sunday worship.

Social media (Facebook and the web site) continue to be the main platform for highlighting church events. Sunday worship services continue to be recorded and through Zoom's online streaming video recordings are being created and available for viewing on both Facebook and the web site. The Facebook page continues to be maintained through the efforts of several LPC Facebook users. The combination of the web site and the Facebook provide complementary views of LPC's impact on the community.

Our 2020 experience has highlighted the value of online platforms like Zoom and provided valuable experience in the use of internet-based services. At the same time, the Vital Congregations Initiative has been helping us focus on the church's history and future direction. As a result, we expect to further refine and expand our marketing and outreach efforts in 2021.
