PASTOR'S REPORT

Dear Church,

2024 was a full and busy year for this congregation. It was my first "full" year as your pastor, although I spent a quarter of that year on maternity leave! We began the year with a Leadership Retreat where the Session, Deacons, and I named our fears and our hopes for this congregation. It was a space to be honest about our very real fears and encouraged by our equally real hopes for what this congregation can be. I think this retreat set the tone for the rest of our year together as we courageously entered into some challenging conversations. We voted to start the Feasibility Study process and hired Heather James as our consultant.

Of course, not everything was a rousing success. We tried a new committee structure, but no one really got the hang of it. Maybe it was the confusing names or maybe it was the half-hearted rollout. Either way- we can say the experiment was a failure so we'll be trying something new next year. The end of my pregnancy was extremely tiring and difficult, so I wasn't able to be the kind of pastor to you that I ordinarily would hope to be. Still, I gave all that I could to my worship leadership, pastoral care, and leadership of the church. I started a monthly (and later, bi-monthly) newsletter to improve communication with the congregation, and that has been well received and it has improved awareness of church events and goings on.

When I went into labor on Palm Sunday, I was disappointed to be missing my first Easter with you all, but incredibly grateful for my colleagues who stepped in to help this congregation keep worshipping together. Ken Sikes from Manitou Park PC led the Good Friday service and Addie Domske started her time as Maternity Leave coverage pastor a week early and got to celebrate Easter with you.

Addie's time as coverage pastor was certainly a wonderful time for this congregation. I could not be more grateful for the way she led and cared for you during those four months. During those months, Addie designed and launched a new website for us, introduced name tags, put signs up around the building, and re-organized the church kitchen with volunteers. She also did a great job preparing me to re-enter my work at the end of my maternity leave, which enabled me to hit the ground running when I returned. Our consultant, Heather James, had to step down due to a cancer diagnosis and Addie agreed to continue working with LPC as our Feasibility Study Consultant.

When I returned from maternity leave, I immediately jumped into worship leadership, pastoral care, administration, and leading the Feasibility Study. In some ways, it felt like a fresh start but with a better foundation than I had a year ago! It's been wonderful to be back into full time ministry, even while staying busy parenting three little kids. Returning from maternity leave reminded me how many things had fallen through the cracks during the pandemic and transition from Barlow to me. There was a lot of loss during those years (people, money, routines, etc.) and I don't think I realized just how much that impacted us until a year into my call. August was full of "ah-ha" moments and I know that it will take time for us to rebuild sustainable systems for leading and growing a functional church together.

Throughout the fall, the Feasibility Study was on the forefront of my mind, both in the day-to-day labors and the long-term implications. I am grateful for the Session's hard work on the process and looking forward to the next phase of our work as we determine what the future of our building and congregation will look like. There is more work ahead of us than behind us, but I see that as good news. We have motivated folks who love this church and want to see us have a bright and beautiful future. In November, I also got to baptize my twins, Eli and Viola, into the family of God which was a particularly special day for me as a Pastor Mom. I feel so lucky to serve a church where my family is not just welcomed but loved. Thank you for being the church who gets to introduce the love of God to my children.

I ended 2024 feeling grateful for all that we have experienced together and hopeful for what 2025 will hold. I am learning and growing right alongside you and I can't wait to see what kind of fruit this next year will produce.

FINANCIAL SECRETARY'S REPORT

The financial pledges of the Lakewood Presbyterian Church congregation during the year 2024 is presented as follows:

The total number of giving units during the past few years has remained relatively stable at 20 units. This year is shown below:

Breakdown for 2024 is

- <u>15</u> Giving units who pledged weekly or monthly
- 6 Giving units who pledged yearly
- <u>2</u> Unpledged giving units that give regular weekly or monthly
 - 23 Total Giving Units

In addition, several persons, visitors and others have contributed occasionally. This is reflected in the Treasurer's report under the category of "Loose Plate" Offering.

A Giving statement is provided at the end of the year for income tax purposes be sure to include your name on your offering envelope otherwise your pledge will be credited to the "Loose Plate" Fund.

TREASURER'S REPORT

Our BUDGET For 2024 was \$165,116 with \$88,000 coming in via giving at the collection plate. We also projected to receive about \$8,400 from our investments in the Morgan Stanley money market. Additionally, we rented space to Wapato Co-op Preschool which brought in \$5,600. All told, we expected to receive \$102,000 from these sources. This left a projected deficit of \$63,116. We expected to have a deficit based on hiring a full-time pastor, as well as increased costs on utilities, security and possible building maintenance, as well as other increases.

We know that we are running a deficit budget but we did plan on this when we hired Pastor Laura as our full time pastor. We do have funds to cover the deficit for another year or so.

We have also conducted the feasibility study to discover how to move forward to keep Lakewood Presbyterian Church as a viable church.

A bright spot to this report is that envelope giving as well as overall General Fund giving was over the budgeted forecast amounts by \$14,171 reducing our overall deficit so our financial picture was better than we thought it would be at the start of 2024.

We continue to receive significant interest from our Morgan Stanley Money Market funds, though it has decreased with the reduction in interest; we actually received about \$7,200. These funds were originally transferred from the Umpqua Bank Money Market where interest was minimal.

Finally, a major contributing factor to our deficit spending was upkeep of the building and grounds. The Building and Grounds report highlights these costs. We hope 2025 sees a reduction in these expenses but 'who knows'.

For those that are new or unfamiliar to the financial information and to clarify the reports, income and expenses are divided into five groups: General Fund, Deacons' Fund, Designated Gifts, Special Offerings and Facility Improvements.

The General Fund, as the name implies, is for the general operation of the church (Pastor's and other salaries, utilities, etc.) These are the income and expenses that relate to the budget.

The other four groups are passed through and are not related to the budget. The income comes in and it goes out without any of the money being used for the ongoing operation of the church. Over time, income and expenditures for these groups will be equal.

• Deacons' Fund is money given to the Deacons' Fund to support the missions of the Deacons

- Designated Gifts are monies given for special purposes like the Memorial Fund or Pastor's Discretionary Fund. These contributions must be used for the purposes for which they were given.
- Special Offering include monies given to the 2 Cent a Meal offering and various denominational offerings like One Great Hour of Sharing, Pentecost, Christmas Joy and Peace Making Offerings. These are all pass-through categories except for a portion of Pentecost and Peace Making offerings.
- The Facilities Improvements consists of the Building Funds: Undesignated, Designated and other designated building fund projects.

We go forward in faith that God will provide.

Areas of focus: Worship, Adult Education, Children, Social.

Lakewood Presbyterian Church has continued its welcoming atmosphere for all and welcome those to "come as they are" and participate in worship, adult and children education and social events. We have had several individuals come and join us regularly weekly while others attend periodically.

Worship:

Our worshipping year began with saying goodbye to our beloved pianist, Jennifer Matson, on Epiphany Sunday. Easter was very early this year, so it was a very short season of Epiphany. On Ash Wednesday, Pastor Laura hosted "Ashes to Go" in the church parking lot during the day and a joint Ash Wednesday service with Manitou Park PC and Fircrest PC. Neither were well attended by LPC members.

For Lent, we did a series on Kate Bowler's book "Have a Beautiful, Terrible Day!" both in worship and in our Adult Ed series. Pastor Laura's last Sunday before her maternity leave was Palm Sunday. Pastor Addie began her time with us on Easter Sunday. Throughout the year, we had the following Pulpit Supply Preachers:

After her return, Pastor Laura has joyfully led us through several worship series and special Sunday which have been unique, and members have shared that they have enjoyed them. (Blessings of the Backpacks, star words for Epiphany, "Conversation Church", 'Words from the Beginning' Advent series, All Saints Day, and "Journey Through the Christian Year" all come to mind). For Christmas Eve, we invited the pastor and members of UMC Lakewood to join us for our Christmas Eve service, which led to our highest attendance service (84) in years! In addition, Laura has engaged the children in engaging children services that help connect them with God.

Thank you to all those who have supported and volunteered their time on Sunday mornings to ensure that we are all able to come together and worship: lay leaders, ushers, sound support, heat support, etc.

Children Education:

In September, we had the "Blessing of the Backpacks" where kids and teachers received a blessing and backpack tag for the start of the new school year. Families were given the book, "Faithful Families" books with ideas for developing spiritual practices with families.

In November, 5 young families within the congregation were gifted a family bible, "The Peace Table" thanks to a \$1000 grant we received from Columbia Theological Seminary (Laura's alma mater). The grant is to support Children's MInistry at our Church. Instead of giving individual children's bibles, we decided to focus on the whole family's faith formation, which is why we decided on "The Peace Table" bibles. The rest of the grant is going to start Godly Play at our church. Godly Play is a creative, imaginative approach to Christian formation and spiritual guidance. Godly Play has a Montessori foundation with 40+ years of research and practice. Godly Play values process, openness, discovery, community and relationships. Godly Play models the worship life, stories, symbols and rituals of Christian congregations. Godly Play allows practitioners to make relevant and personal theological meaning. Godly Play nurtures participants to larger dimensions of belief and faith through wondering and play.

Becky Buescher has graciously continued her work with the school age children and leading the young Christian education. She leads using "Feasting on the Word" Curriculum and collaborating with Pastor Laura and supplementing to support and align with Sunday Worship and themes.

Adult Education:

Adult education classes have been revitalized through two book series this year, "Have a Beautiful, Terrible Day!" during Lent and The Reformation Project's "How To Talk About the Bible & LGBT Inclusion" in June. In December, we had an intergenerational Sunday School class that followed our Advent series, which was a fun but sometimes challenging experiment. We are still learning how to do intergenerational events well. Looking forward to all the upcoming year has a Grief Group and new Class on the Book of Confessions.

Social Events:

LPC has held wonderful events that were full of laughter and joy for all those who attended. Events held included: Cinco de Uno, Annual Potluck, Popsicles with Pastor Laura, Harvest Festival, Chili cookoff with pumpkin carving, and Christmas bingo and cookie swap.

<u>"MINISTRY IN THE COMMUNITY"</u> <u>COMMITTEE REPORT</u>

The Committee on Ministry in the Community has the role of looking for ways the church can learn more about the greater church (PCUSA) and ways to impact the community. Lakewood Presbyterian has done many things which have filled this objective in the past, such as the Hunger Walk. Other projects have been taken up by the deacons which benefit people outside the congregation. The new committee's task is to look for new educational opportunities and activities, especially looking at PCUSA's initiatives, to enhance our impact on society.

At the session/deacon retreat in January, it was voted to investigate activities of Retreat home (homelessness) and More Light Presbyterians (LBGTQ issues). Many of the projects seemed larger than our small congregation can take on at the present time but could become more educated on the subjects. The minister from Hagar's Church (Women's Prison at Purdy) spoke to us and we gave the church an honorarium. The session also voted to endorse the mission statement of More Light Presbyterians: "Following the risen Christ, and seeking to make the Church a true community of hospitality, the more Light is to work for the full participation of LGBTQ people in the life, ministry and witness of Presbyterian Church (USA) and in society."

Our church has had an interest in environmental causes in the past and the committee voted to work on projects to help our planet. Chris Piatt agreed to be the chair of this newly formed team – Congregational Earth Care Team (see report below). The church continues to be a member of Faith Action Network and endorsed a No vote on initiative 2117 at election. The No vote was successful. Plans are to continue to work on educational items and seek projects that will help Lakewood Presbyterian Church have a positive footprint in the community at large.

EARTH CARE

The Session Retreat at the beginning of the year identified earth care as a mission priority for LPC and began considering the possibility of using guidelines from **Presbyterians For Earth Care** to build an Earth Care Team for our congregation. PEC is a non-profit organization that was formed in 1995 to help the PC(USA) carry out the 1990 policy, Restoring Creation for Ecology and Justice.

The Session-led Ministry In the Community Committee recruited congregation members to be on the team, with the purpose being to educate and engage the congregation in work needed to care for God's creation, and to integrate creation care into our witness and ministry. The Earth Care Team was formed and met during the year, consisting of Connie Dunkelberger, Jennifer Rogiers, Margie Callahan, Parker Williamson and Chris Piatt, with attendance and support by both Pastor Addie and Pastor Laura.

Our first project was to share information about climate change with the entire congregation through a series of videos during September Moments for Mission. These videos were narrated by Katherine Hayhoe, who is both a highly regarded climate scientist and an evangelical Christian. As she was standing by a polar bear, she explained very poignantly that science tells us our choices matter, and our faith tells us what's the right thing to do.

Next, following PEC guidelines, the Earth Care Team facilitated a full congregational earth care meeting on September 22. We introduced the team and explained our goals. We asked for ideas about what LPC values most, and what we should prioritize in planning future events and activities. Refreshments were provided by the Earth Care Team, demonstrating these earth stewardship practices:

- limiting single-use, throw-away plastic items;
- using local foods that don't require long distance shipping;
- highlighting plant-based food choices.

Many ideas were mentioned in our brainstorming, including activities for kids, a harvest event, recycle bins/signs, advocacy to preserve Lakewood tree canopy, speakers/educational events, and researching grants for ideas for green church building improvements.

Our final activity for the year was setting up a kid's art table at the church Harvest Festival. We supplied leaves and information about native trees so that they could create a crayon rubbing, and learn something about the value of trees.

BUILDING AND GROUNDS

2024 was an expensive year for Building and Grounds with two Roof Repairs, two Plumbing Repairs, Electrical work and an Ant invasion.

In January/February we had leaks in the kitchen area which were repaired for **\$5300** in early March.

In April we had a toilet in the Nursery stop operating due to an alignment issue with old cast iron pipes. The pipes were aligned and water jetted to clean out debris. The cost was **\$4684**.

In May we experienced more roof leaking in the kitchen and fellowship area. We received a bid of \$16,200 and it eventually came in at **\$15,000**. It was completed in December.

We also had an ant infestation and hired an exterminator in July and the cost was **\$434.90**.

In November, we had another plumbing issue when the toilet stopped working and we discovered that the cast iron pipe was creating issues with the waste and paper being hung up on the cast iron. We installed a cleanout, descaled the cast iron pipe and jetted the pipe to remove the scale that had been removed. The cost for this service was **\$7772.00**. We also installed a pressure toilet in the nursery to help with the flow of sewage through the system.

Finally, we had electrical work done to allow for an external camara. Laura is often at the church after dark and we wanted to make sure that she could see if anyone was outside when she leaves. That electrical work was **\$600**.

Total repairs cost us \$33,790.

We also had two grounds clean-ups (March and July). As you can tell from the above report, we are very challenged at maintaining the building and grounds. We welcome any help to keep the facility in good condition.

We hope plumbing issues are taken care of and coming repairs will be minor. Who knows.
